Your Dues Working For You: Medicaid Telehealth Update

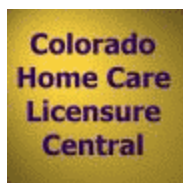
This edition of the *HCAC Management Report* features an update on Colorado Medicaid's telehealth program.

Colorado's Dept. of Health Care Policy & Financing discussed progress on the implementation of Senate Bill 07-196 (the Home Health Telehealth bill) at a statewide audio-conference on Oct. 27th. Many HCAC members attended and supported the association's telehealth efforts that resulted in the passage of the bill in 2007.
